The AFI Symposium is a **peculiar event** where Exhibition and Conference coexist. **It has been a reference for all stakeholders in the World of Healthcare for over 60 years.**

The 2023 edition was attended by **1.700 Participants** and **130 Exhibitors**. The dedicated Website generated a traffic of **16,000 visitors** during the year, with over **60.000 page views**. The Social Plan on LinkedIn was developed through about **220 post**, including posts dedicated to Exhibitors, with a total of almost **180,000 views**.

The 62nd AFI Symposium will be held from 5 to 7 June 2024 at the Palacongressi di Rimini. The themes of this edition will be innovation, research and sustainability. The Exhibition Area, expressly conceived to make the visit more interactive, dynamic and personalized, has been reconfirmed and further expanded, facilitating networking and business opportunities

The **institutional corners and a series of parallel events** have also been reconfirmed, making the Exhibition Area alive and pulsating.

The AFI Symposium will deliver **highly topical scientific contents**, during **Scientific Sessions** and **Lectio Magistralis**, with the participation of speakers from Companies, Institutions, Universities and national and foreign Trade Associations. The programme also includes **Workshops** which will open the event as usual on Wednesday morning.
