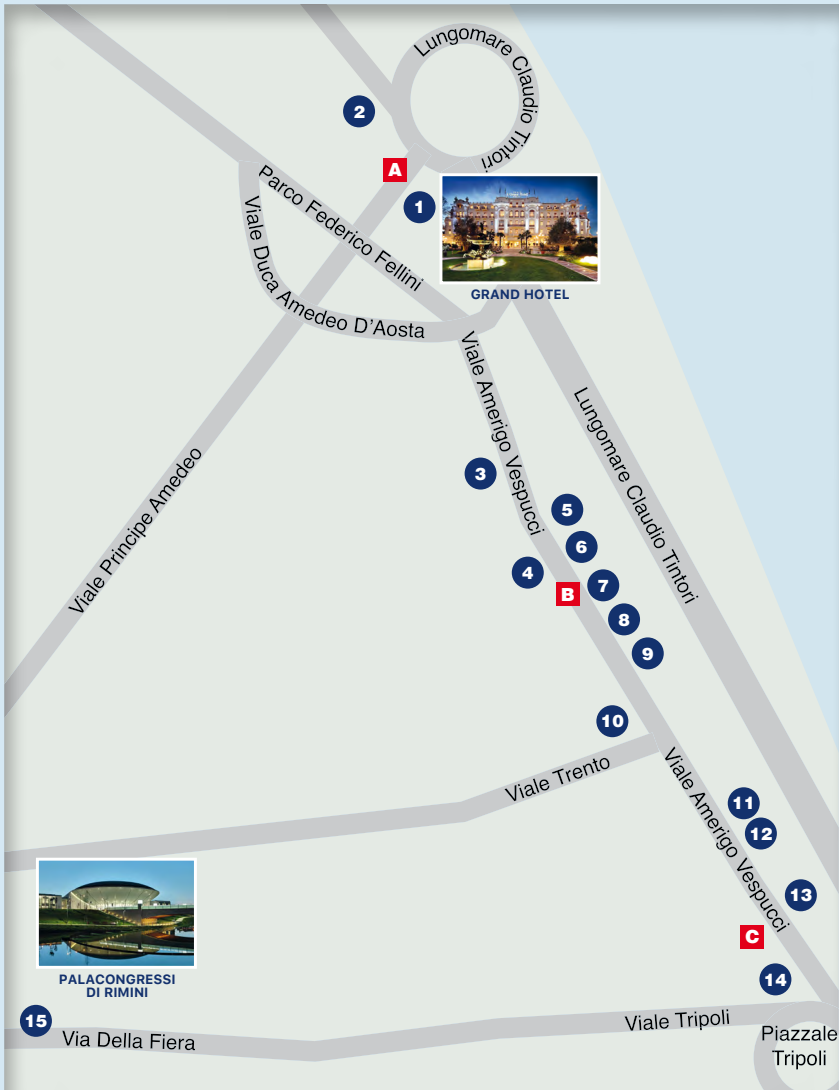

Data controllers, who provide you with the following information:

1. The information in this communication concerns all your personal data that you provide directly to us, as well as other data relating to you that will be acquired in the future.
2. The treatment of the data happens for purposes related to the management of the registration to participate in the 64° AFI SYMPOSIUM - RIMINI – 11/12/13 JUNE 2025 which you ask for registration. The legal basis for the processing is the execution of a request by the data subject and the legitimate interest of the data controllers to manage the data of the participants in an effective way in order to promote the knowledge of information of interest to the operators of the sector and to encourage networking. Legal basis for the processing is the consent of the data subject
3. The data will be entered into a database and / or stored for the time strictly necessary in relation to the purposes set out above, in paper files or on magnetic media and will be processed by us manually or through the use of electronic systems, telematics and any other means made available by technology and technological development in accordance with the law. The data will be processed lawfully and correctly and, however, such as to ensure the security and confidentiality of the data.
4. The provision by you of data for the purposes mentioned above is optional. Your refusal to provide the data may make it impossible for the owners to carry out the planned activities.
