From knowledge to digitalization for competitiveness of the health industry

The 64th AFI Symposium on "From knowledge to digitalization for competitiveness of the health industry" will take place as usual at the Palacongressi of Rimini from 11th to 13th June 2025.

In recent years, the healthcare industry has undergone a profound transformation due to the advent of digitization. The integration of such technologies into the processes of different industries in the sector has the potential to revolutionize the way patient services are delivered, improving efficiency, accessibility and quality of care. We are therefore witnessing the evolution of traditional knowledge through digitization, which is also a key factor in improving the competitiveness of the sector.

Doctors, researchers and health professionals rely on years of study and experience to diagnose diseases, develop treatments and improve care. Continuous education and updating skills are essential to stay abreast of new scientific discoveries and best practices. Digitization makes it possible to collect, store, and analyze huge volumes of data more efficiently, data that become immediately available where it is most needed, such as for timely and personalized diagnosis and treatment. Thus, a paradigm shift is occurring in the way knowledge is collected, shared, and applied in the health sector, thanks in part to new technologies that can be applied such as artificial intelligence (AI) and machine learning, the Internet of Things (IoT), and blockchain, which are transforming the way in which data is managed, improving the accuracy of diagnoses and optimizing treatments.

In this context, telemedicine services and new types of medical devices have been developed, such as wearables, that enable real-time monitoring of the patient's health, with a more effective chronic disease management and continuous remote control.

In addition, digitization fosters collaboration among hospitals, laboratories, pharmaceutical companies and other healthcare stakeholders through integrated systems, useful for sharing information quickly and safely, improving care coordination and accelerating research. However, it should be remembered that investment in digital skills training, aimed at the staff involved, is a fundamental prerequisite to ensure that the health industry can take full advantage of all potential benefits.

This transition from traditional knowledge to digitization is thus transforming the entire healthcare supply chain, making it more efficient, competitive, and future-oriented, with significant improvement for access and quality of medical treatments.

The concepts of "knowledge and digitization," which give the 64th Symposium its title, will permeate all sessions.

This edition of the AFI Symposium will include 18 Scientific Sessions, 2 Keynote Lectures, numerous side events, including the Poster Session, Corporate Workshops, in-person on Wednesday morning and digital, featuring authoritative speakers from the Industry, Universities, Institutions and Trade Associations.

The Symposium will start on Wednesday afternoon with a speech by Giorgio Bruno, AFI President, followed by the Keynote speech by Lucio Poma, Nomisma Chief Economist, who will focus on the theme: 'Shifts in the healthcare world'. This will be followed by the three sessions scientific sessions on Sustainability, Innovation and Clinical Research.

Thursday morning will feature sessions on HTA, Regulatory, Quality, Biotech, Special Productions, PVV and Poster, during which participants will be allowed to showcase the results of their projects, ending with an award ceremony for the best posters, which will still remain on display throughout the Symposium in the dedicated area.

Thursday afternoon will feature the **Keynote Lecture**, by Roberto Burioni, Ordinary Professor of Microbiology and Virology at the University Vita-Salute San Raffele di Milano, followed by the sessions Medical Devices, Supply Chain, Pharmacovigilance, AFI/SITELF Pharmaceutical Sciences and CRS – SITELF.

To conclude, Friday morning will feature the last four sessions on **Production**, **Digital Health**, **Raw Materials** and **Social Trends** and **Phenomena** in the **Pharmaceutical Supply Chain**.
